Greentown Town Council Meeting

JULY 18, 2023

Meeting was called to order by President Scott Deyoe.

Minutes of Previous Meeting: The minutes of the previous meeting (06/20/23) were presented for additions or corrections. Mr. Deyoe asked for a motion to accept the minutes. Motion was made by Mr. Standish. Motion was seconded by Mrs. Everling. Motion carried.

Approval of Dockets: General Fund total expenses for June 21st – July 18th were \$181,914.54. Water Fund was \$61,108.50. The Wastewater Fund totaled \$185,336.95. The Stormwater Fund was \$37,033.84. The Council received Fund Appropriation Reports and Payroll Check Registers for payroll ending 06/25/23, 06/30/23 & 07/10/23 in caucus prior to the Town Council meeting. Mr. Deyoe asked for a motion to accept. Motion was made by Mr. Lantz. Motion was seconded by Mr. Skinner. Motion carried.

Items from Attorney: Mr. Peelle informed the Council that he sent a letter to David Henderson, 205 Holiday Drive, requesting payment for unpaid Dog tickets in the amount of \$250.00. Mr. Henderson is declining to pay the town's ordinance violation. Mr. Peelle asked the Council if they wanted to file this matter in small claims court. Consensus of the Council is to have Mr. Peelle file this issue in small claims court.

2022 CCMG Project – Change Order #1 & Pay Application #1: Mr. Deyoe read the Change Order No. 1 for the 2022 Community Crossings Road Improvement Project with E&B Paving, LLC. Original Contract Price - \$625,738.99. Increase Change Order - \$12,724.92. New Contract Price - \$638,463.91. Mr. Deyoe asked for a motion to approve Change Order No. 1 in the amount of \$638,463.91. Motion was made by Mr. Skinner. Motion was seconded by Mrs. Everling. Motion carried.

Mr. Deyoe read the Pay Application No. 1 from E&B Paving, LLC for the 2022 CCMG Project. Total Complete/Stored/Pending = \$638,463.91 Less Retainage 5% = \$606,540.71. Mr. Deyoe asked for a motion to approve Pay Application No. 1 to E&B Paving, LLC in the total amount of \$638,463.91. Motion was made by Mr. Lantz. Motion was seconded by Mrs. Everling. Motion carried.
