RESOLUTION AND MEMORANDUM OF UNDERSTANDING
BETWEEN EASTERN HOWARD SCHOOL CORPORATION AND
THE TOWN OF GREENTOWN FOR PLAYGROUND CONTRIBUTION

WHEREAS, the Town Council of the Town of Greentown has certain funds available to it for the benefit and well-being of its residents and children; and

WHEREAS, the Eastern Howard School Corporation is building and / or renovating playground facilities located in the Town of Greentown on its property; and

WHEREAS, the parties agree it is mutually beneficial to the each of them for the Town of Greentown to donate certain funds to assist Eastern Howard School Corporation with it's playground project; and

WHEREAS, I.C. 36-10-2-5 allows a town to aid or maintain neighborhood centers or community centers or facilities; and

WHEREAS, the playground project will benefit the residents of the Town of Greentown by serving as a recreational exercise facility and playground;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GREENTOWN, INDIANA, THAT:

Section 1. The Town Council of the Town of Greentown approves a donation of \$10,000.00 from the Cumulative Capital Development Fund (Fund 4402) and \$15,000.00 from the Economic Development Local Income Tax Fund (Fund 2209) to the Eastern Howard School Corporation to assist with maintenance and construction of a playground facility which may be utilized by the residents of the Town of Greentown as authorized by Indiana Code 36-10-2-5;

Section 2. The Town Council of the Town of Greentown directs the Clerk-Treasurer to send the aforementioned funds to the Eastern Howard School Corporation no later than December 31, 2025;

Section 3. The aforementioned assistance shall be made to the Eastern Howard School Corporation upon the express condition and understanding that it shall be utilize solely for purposes of maintaining and /or updating playground facilities located on the Eastern Howard School Corporation property from time to time as needed and that residents of the Town of Greentown shall have free use and access of the playground facilities;

Section 4. The sections, paragraphs, sentences, clauses, phrases and words of this Resolution are separable, and if any word, phrase, clause, sentence, paragraph or section of this Resolution shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Resolution.

Section 5. This Resolution shall be in full force and effect from and after its passage and approval by the Town Council of the Town of Greentown.
